**PUBLIC HEALTH ACT (DANGEROUS INFECTIOUS DISEASE) (AMENDMENT) (No. 9) REGULATIONS 2020,
made by the Board pursuant to Section 102 of the Public Health Act, Cap. 353.**

1. Citation and commencement

(1) These Regulations may be cited as the Public Health Act (Dangerous Infectious Disease) (Amendment) (No. 9) Regulations, 2020.

(2) This regulation shall come into effect at 11:00p.m. on Thursday the 3rd day of September, 2020.

2. Interpretation

In these Regulations –

“principal Regulations” means the Public Health Act (Dangerous Infectious Disease) Regulations 2020, Statutory Instrument No. 16 of 2020

3. Amendment of Regulation 5A, paragraph 9

The principal Regulations are amended in paragraph 9 subparagraph (1) (b) by repealing subparagraph “(b)” in its entirety and substituting the following—

“(b) attend or participate in any organised sporting event or any sports stadium unless approval has been granted for such event by the relevant authorities; or”.

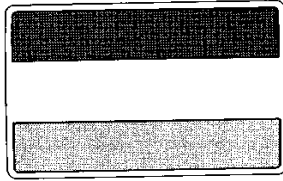

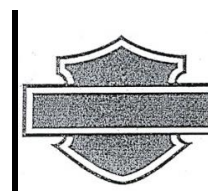
