WHEREAS section 4 of the Land Acquisition Act, Cap. 233 provides that if it appears to the Cabinet that any land is likely to be required for any purpose which, in the opinion of the Cabinet is a public purpose and it is necessary to make a preliminary survey or other investigation of the land, they may cause a notification to that effect to be published in the Gazette and at the same time in notices to be exhibited at suitable places in the locality in which the land is situate; and
