**NOTIFICATION DATED THE \_\_\_\_ DAY OF \_\_\_\_\_ 2022 MADE BY THE CABINET UNDER SECTION 4 OF THE LAND ACQUISITION ACT, CAP. 233 FOR THE PURPOSE OF CONDUCTING A PRELIMINARY SURVEY OR OTHER INVESTIGATION OF CERTAIN PARCELS OF LAND LIKELY TO BE ACQUIRED FOR A PUBLIC PURPOSE**

**WHEREAS** section 4 of the Land Acquisition Act, Cap. 233 provides that if it appears to the Cabinet that any land is likely to be required for any purpose which, in the opinion of the Cabinet is a public purpose and it is necessary to make a preliminary survey or other investigation of the land, they may cause a notification to that effect to be published in the Gazette and at the same time in notices to be exhibited at suitable places in the locality in which the land is situate; and **NOWHEREFORE IT IS HEREBY NOTIFIED** that the Cabinet, upon the advise of the Consultant for the Antigua and Barbuda Feasibility Study for the Road and infrastructure Project, considers that the parcels of land described in the Schedule hereto are, in the opinion of the Cabinet required for a public purpose, and that the provisions of section 4 of the Land Acquisition Act Cap. 233 be enforced in the manner prescribed by the Act.
