## (CENSUS OF POPULATION) ORDER 2025

2025, No. 17

The National Bureau of Statistics (Census of Population) Order, 2025, made by the National Bureau of Statistics in exercise of the powers conferred upon it by section 9A of the National Bureau of Statistics Act, 2013, as amended.

## 1. Short title

This Order may be cited as the National Bureau of Statistics (Census of Population) Order 2025.

#### 2. Census of Population

The National Bureau of Statistics hereby directs that a census of population shall be taken for all inhabitants of Antigua and Barbuda.

#### 3. Date of Census

The census of population directed under paragraph 2 of this Order shall be taken between the 25<sup>th</sup> day of June, 2025 to 30<sup>th</sup> of December, 2025.
